## Objective

Expanding AAPI access in language to gov services

## Our Role

Take leadership role in existing coalitions and propose equitable language policies

## Strategies in Action

Direct Services	<ul style="list-style-type: none"><li>• increase inter-unit communication</li><li>• translate materials</li><li>• collect stories / trends / needs</li><li>• trainings re what current fed/state standards are</li></ul>
Policy	<ul style="list-style-type: none"><li>• identify state statutes governing language access and whether agency follows such rules</li><li>• implementation of office of language access</li></ul>
Impact Lit	<ul style="list-style-type: none"><li>• enforce existing language access laws</li></ul>
Commun. Eng.	<ul style="list-style-type: none"><li>• educate community how to vocalize and get their voice heard</li><li>• collaborate with CBO for more education</li><li>• social media and media interviews</li></ul>
Demo Research	<ul style="list-style-type: none"><li>• collect, analyze, and provide data support on language access needs</li></ul>

# New Migrants

## Objective

To build a local and multi-state network to protect and promote the rights of AAPI migrants

## Our Role

AJSOCAL will convene coalition of AAPI-serving orgs to be the voice of AAPI migrants in broader immigration justice networks

Policy	<ul style="list-style-type: none"><li>• identify past creative solutions / funding allocations for migrants</li></ul>
Impact Lit	<ul style="list-style-type: none"><li>• develop lit strategy in areas impacting new migrants (e.x trafficking, employment)</li><li>• including litigation in forums outside LA/OC</li></ul>
Commun. Eng.	<ul style="list-style-type: none"><li>• outreach</li><li>• community engagement</li></ul>
Demo Research	<ul style="list-style-type: none"><li>• monitor and track border encounter trends</li><li>• gather data (from orgs and community) on AAPI migrants and their needs</li><li>• research history and identify learning opportunities from refugee resettlement issues</li></ul>
