

***Citizenship Application Workshop
Information and Documents to Bring***

Please bring the following to the workshop:

- A **copy** of your **Permanent Resident Card** (also known as your “green card”) – back and front sides.
- Your **driver’s license** or state identification card.
- Your **passport**.
- Your **Social Security number** (we do not need the card itself).
- Filing Fee
 - A. **Check or money order**, payable to “*U.S. Department of Homeland Security*”, with A-number on memo line
 - \$725 (if under 75 years of age)
 - \$640 (if 75 or older)
 - B. **I-942 “Request for Reduced Fee”** and check or money order, payable to “*U.S. Department of Homeland Security*”, with A-number on memo line
 - \$405 (if under 75 years of age)
 - \$320 (if 75 or older)
 - C. **I-912 “Request for Fee Waiver”** and supporting documentation

- A list of your **residences** for the past 5 years.

If your mother or father is a U.S. citizen, please provide:

- Name of U.S. citizen parent

If you are a male living in the US at any time between your 18th and 26th birthdays, you were required to register for selective service. If you did not register for Selective Service, you must obtain a status information letter from the Selective Service System

If you want to apply for a fee waiver:

- Most recent tax return forms with all W2s, attachments, and schedules
- Official letter from government, if you receive any government benefits
 - Attach a recent letter, notice or other official document dated within the last 3 months that shows: (1) the name of the person receiving the benefit and (2) the name of the agency that is providing the benefit
